## Skopabsh Celebration Muckleshoot Indian Reservation

August 20, 21, 22, 2010

1) The following fee schedule for the Muckleshoot Skopabsh Celebration 2010 is:

**FOOD: \$300.00(10x10); \$350.00(10x20); \$400(20x20)**  
**ARTS/CRAFTS: \$150.00(10x10); \$200.00(10x20); \$250(20x20)**

- 2) All booth spaces will be assigned in the order the application and deposit (1/2 of the fee) is received, first come, first served. Absolutely NO Refunds.
- 3) Setup can begin on Monday, August 16, 2010.
- 4) One (1) paid space per vendor, unless additional space is approved and paid in advance. NO motor homes, canopies, tents, etc. are allowed for personal camping purposes in the vendor area. You must setup your tent in the camping area.
- 5) You may drive your vehicle in the vendor area to load and unload only. No vehicles are allowed to drive in unauthorized areas unless guided by an OFFICIAL. Vehicles cannot be left unattended. NO EXCEPTIONS.
- 6) Absolutely no alcohol, drugs, firearms, weapons, or fireworks are allowed on the premises or stored in the vendors' vehicle. No sharp, dangerous objects can be sold on the premises. NO EXCEPTIONS.
- 7) Electrical hookup and water will be available. You must provide your own electrical cords and hoses.
- 8) You must take your own trash to the dumpsters. Do not use the trash cans. The trash cans are for our guests and should not be used as a dumpster.
- 9) Security will be in service, but PLEASE take all money and valuables with you at night. THE MUCKLESHOOT INDIAN TRIBE AND LIVE NATION WILL NOT BE HELD RESPONSIBLE FOR THE THEFT OF OR DAMAGE TO YOUR PROPERTY.
- 10) YOU MUST PROVIDE A COPY OF YOUR FOOD HANDLERS' PERMIT AT THE TIME OF APPLICATION. You must openly display your vendor permit and food handlers' permit in your stand.
- 11) All complaints must be in writing and directed to the Muckleshoot Indian Tribe Powwow Committee.
