1) The following fee schedule for the 2019 Muckleshoot Veteran's Powwow is:

**Arts/Crafts:**     10x10 (\$150)     10x20 (\$200)     20x20 (\$250)

**Food:**     10x10 (\$300)     10x20 (\$350)     20x20 (\$400)

**Drinks/Snacks:**     10x10 (\$200)     10x20 (\$250)

- 2) All booth space will be assigned in the order of completed application and payment is received.
- 3) Setup can begin on Tuesday, June 18th, 2019
- 4) One (1) paid space per vendor, unless additional space is approved and paid in advance. Vendors will be **charged \$50** per every additional 10 ft. No motor homes, canopies, tents, etc. are allowed for personal camping in the vendor area. You must setup your tent in the camping area.
- 5) You may drive your vehicle in the vendor area to load and unload only. No driving on the grass. No vehicles allowed in unauthorized areas unless guided by an OFFICIAL. Vehicles cannot be left unattended.
- 6) Electrical hookup(s) and water will be available. You must provide your own electrical cords and hoses.
- 7) Craft vendors are limited to 1 electrical outlet per booth. Food vendors are limited to 2 electrical outlets **per booth. Additional outlets needed by vendors will be charged \$25 an outlet.** No large appliances over 500 watts.
- 8) You must take your own trash to the dumpsters. Do not use the trash cans. The trash cans are for our guests and should not be used as a dumpster.
- 9) YOU MUST PROVIDE A COPY OF YOUR FOOD HANDLERS' PERMIT AT THE TIME OF APPLICATION. You must openly display your vendor permit and food handlers' permit in your stand.
- 10) Art/Crafts must be authentic Native American products unless given permission prior by an OFFICIAL. We will not allow vendors to sell reproductions or imported "Native American" products.
- 11) **No Arts/Crafts vendors are allowed to sell food in their stations. If an Arts/Crafts vendor is selling food at their station they will be fined with an additional \$300.**
- 12) **NO PETS ARE ALLOWED ON THE POWWOW GROUNDS OR VENDOR AREAS! NO EXCEPTIONS**
- 13) Inappropriate toys such as projectile toys (sling shots, guns, catapults, or marshmallow guns), real-like weapons & fake tobacco products (such as cigars and cigarettes) WILL NOT BE ALLOWED ON THE PREMISES.
- 14) All complaints must be in writing and directed to the Muckleshoot Indian Tribe Powwow Committee.
- 15) ABSOLUTELY NO REFUNDS
- 16) Absolutely no alcohol, drugs, firearms, weapons, or fireworks are allowed on the premises or stored in the vendors' vehicle. NO EXCEPTIONS.
- 17) Security will be in service, but PLEASE take all money and valuables with you at night. THE MUCKLESHOOT INDIAN TRIBE WILL NOT BE HELD RESPONSIBLE FOR THE THEFT OF OR DAMAGE TO YOUR PROPERTY.
