***Completed Applications, Food Vendors: Proof of Food Handlers Card, and Full Payment must be submitted before Setup.**

1. All Vendors must complete and sign the Vendor Application Form. All payments must be paid prior to setup on Friday, July 29, 2022. **NO EXCEPTIONS!!**

Acceptable forms of payment, including Cashier's Check and Money Orders need to be made payable to Muckleshoot Indian Tribe and accompany your application. **(NO PERSONAL CHECKS ACCEPTED).**

2. Prices for spaces are as follows (rates are the entire weekend)
 - 10 x 10 space \$150.00
 - 10 x 20 space \$225.00
 - 20 x 20 space \$275.00
 - One Day \$ 60.00
 - Informational Booths, No Charge

(No selling of merchandise, food or raffle tickets from information booths)
3. All Booth spaces are subject to prior approval. No unauthorized vendors will be allowed.
4. Booth spaces are limited and will be issued on a first come, first serve basis.
5. To ensure the safety of all of our guests, all food vendors will be **required** to have a **valid** food handler's permit/card.
6. Electricity and Water will be provided at no additional charge. Due to limited resources, power and water will be provided on a first come, first serve basis only.
7. All Vendors will be allowed to set-up beginning on Wednesday, July 27, 2020 at 9:00am. **NO ONE WILL BE ALLOWED TO ENTER BEFORE THAT TIME.**
8. Vendors will be allowed to unload at the site of their booth, **but must park their vehicle in the general parking area.**
9. Vendors are responsible for keeping their area clean at all times.

10. Overnight camping is available, at the campsite.
11. The Pow Wow Committee reserves the right to prohibit vendors from selling or displaying any items which are disturbing to the attending community at the Pow Wow.
